REGULAR MEETING

The Regular Meeting of the Hempfield Township Board of Supervisors was held on Tuesday evening, March 7, 2023, at 7:00 P.M. in the Township Municipal Building.

All of the Supervisors were present. Also present were Richard Stanley of 8 Fox Creek Drive, Dana Beilstein 37 Webster Drive; Dave Whaling of 6 Buena Vista Drive and Caleb Stright of the Record-Argus.

Chairman Gary Hittle called the Regular Meeting to order.

Chairman Hittle opened the meeting for Public Comment. Dana Beilstein of 37 Webster Drive asked the Supervisors if anything could be done about the residents living at 14 Conneaut Lake Road. They burn trash and illegal substances, leave the pets out unattended and the property is not being maintained. Supervisor Hittle stated the residents need to call 911 and ask for the on-duty Hempfield Township Police officer when they are burning illegally or if the pets are out roaming the neighborhood. He also stated paperwork has been sent to the property owner identifying the Property Maintenance Violations. If they are not abated, charges will be filed with the local District Magistrate's Office. Mr. Beilstein thanked the board for working to clean up the situation that is disrupting the neighborhood.

Chairman Hittle said he would entertain a motion to approve of and dispense with the reading of the Minutes of the Regular Meeting of February 7, 2023. Supervisor Geisel made the motion to approve of and dispense with the minutes. Supervisor Hittle duly seconded the motion and it was unanimously approved by Chairman Hittle. Motion carried. Chairman Hittle said the minutes are a public document and may be viewed during regular business hours at the Township Building.

Exonerations have been requested by Tax Collector Robert Ohr for 2023 totaling \$2,141.20. Secretary Hittle stated the assessed value of the exonerations is \$233,500 from 9 parcels. After no discussion on the topic, a motion to approve was made by Supervisor Geisel and it was duly seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried.

Chairman Hittle said Township Supervisors need to reappoint a delegate and alternate to the Act 32 earned income tax collection committee for Mercer County. Secretary Hittle read Resolution R11-2023 in full. Supervisor Geisel made a motion to appoint Gary E. Hittle as the delegate for Hempfield Township and Todd P. Hittle as the alternate delegate. This motion was seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried.

Resolution R10-2023 was prepared to add the Richard Conlon Subdivision as a revision to the Township's Sewage Facilities Plan through the installation of a small flow treatment facility. Secretary Hittle read Resolution R10-2023 in full. There was no discussion. Supervisor Geisel made a motion to approve Resolution R10-2023 as presented and it was seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried.

Chairman Hittle stated if Township Residents have any questions filing their 2022 local wage taxes to contact the local Berkheimer office at 724-347-7607.

Chairman Hittle said the Supervisors need to approve participation by the Hempfield Township Volunteer Fire Department members in upcoming activities. They Are; March 2,9,16,19 and 23 training and membership/directors meeting on March 13. Supervisor Geisel made a motion to approve participation in the aforementioned activities by VFD members. It was duly seconded by Supervisor Hittle and unanimously approved by Chairman Hittle. Motion carried.

Next on the Agenda is the viewing of reports of the various Township departments for the month of February. The police report was first presented. The men worked 796 man hours and traveled 4,185 miles. They issued 1 traffic citation. There were 12 accidents with 1 injury. There were 50 criminal-related incidents, 390 service incidents, 30 police information, and 56 additional traffic related incidents. There was \$557.31 in property stolen with all recovered and no property damage reported.

For the month of February for the Hempfield Township Volunteer Fire Department, there were 12 Fire calls. Aid was given 1 time and Aid received once.

There were 3 zoning permits issued for the month of February. They were issued to Justin McGonigle of 208 Hempfield Avenue for a Master Closet at an estimated market value of \$800.00; Justina Glaize of 10 Grove Street for a Home Addition at an estimated market value of \$73,500.00 and Traci Gosser of 128 College Avenue for a fence at an estimated market value of \$1000.00.

The Township Maintenance Crew report was reviewed next. Anti-skid/salt was mixed, Township roads were scraped of snow drifts and slush; Cut and removed downed tree off St. Glory Road; Cleaned ditches on Salem Road; Cleaned catch basins in Country Estates Development; Serviced weed eaters for summer maintenance; Cleaned out salt spreaders; Picked up parts for zero turn mowers at Boyd's Lawn & Garden; Sharpened mower blades on zero turn mowers; Painted and straightened brackets on Toro Zero Turn Mower; Washed plow trucks and HTPD vehicles; Trip to McCandless Ford for HTPD vehicle parts; Cut up downed trees and limbs at Park; Cleaned parking lot at Township Building; Worked on hauling trailer; Worked on HTPD Unit#3; Worked on GMC Bucket Truck; Worked with Mobile Inspection LLC on Dielectric Test on Boom on GMC Bucket Truck; Worked on 99 International Dump; Worked on HTPD Unit#1; Marked numerous PA One Calls; Cleaned around Township Building; Opened stormwater, cross pipes along Township Roads after rain storms; Worked on HTPD Unit#2; Took HTPD Unit#1 for inspection; Working with Sewer Specialty Services on HTMA maintenance project; Located manholes on East Stewart Ave; Ditching along Quarry Hill and Gruber Roads.

Chairman Hittle opened the floor to the miscellaneous portion of the meeting for any additional comments from the Board or public. There was none.

Chairman Hittle said that prior to adjournment, a motion should be made and seconded that checks be issued in payment of all utility bills, and that all other bills be checked and upon approval, be paid. The motion was made by Supervisor Geisel and duly seconded by Supervisor Hittle. The motion was unanimously approved by Chairman Hittle. Motion carried.

There being no further business, Supervisor Hittle made a motion to adjourn. Supervisor Geisel duly seconded the motion and it was unanimously approved by Chairman Hittle. Motion carried.

Chairman Hittle declared the meeting adjourned.
