- *The Supervisors remind all Township residents that every resident who had Earned income from any source during the calendar year of 2024 must file a Township wage tax return with Berkheimer Tax Administrators on or before April 15, 2025. This return is required even though, in most instances, the wage tax has been withheld by the employer. This return is required regardless of age, amount of earnings, or place of employment. Information can be obtained from the Berkheimer Office in Hermitage, PA or on their website. Those who have or will ask the IRS for an extension are also required to notify Berkheimer.*
